Introduction

Act 63 SLH 2021, requires the Department of Human Resources Development (DHRD) to review the classification and compensation schedules for telephone and emergency dispatchers and employees who perform similar functions and submit a report to the legislature recommending modifications to those classification and compensation schedules. Act 63 describes positions that perform telephone and emergency dispatcher type of work as follows:

- 1. Telecommunications dispatchers, including police, fire, or emergency medical dispatchers, any Hawaii state hospital telephone operators or call takers, and any persons who perform any combination of these functions;
- 2. Emergency dispatchers; and
- 3. Any other telecommunications dispatch personnel who, while operating a 911 automated terminal, uses multiple robust lifesaving procedures and technologies to obtain critical information from the caller, analyzes the information given and, from specialized mapping systems, sends the appropriate and closest available emergency unit, and communicates the best course of action for the caller to take before the arrival of that unit.

HRS §89-9 states that the employer and the exclusive representative shall meet to negotiate in good faith with respect to wages, hours, and other terms and conditions of employment which are subject to collective bargaining. Wages are determined through this collective bargaining process and mutually agreed between the employer and union. When an agreement cannot be reached, the impasse is sent to an arbitration panel who issues an arbitration decision.

Pursuant to HRS §76-13.5, each director shall establish, implement, and maintain one or more classification systems covering all civil service positions, not otherwise exempted by rules. The classification systems shall be constructed with the objectives of achieving equal pay for equal work as provided in HRS §76-1. The classification systems in each jurisdiction, in accordance with HRS §89-6 (c), differentiate blue collar from white collar employees, professional from institutional, health and correctional workers, supervisory from nonsupervisory employees, teachers from education officers, and faculty from nonfaculty.

In accordance with HRS §76-1, equal pay for equal work shall apply between classes in the same bargaining unit among jurisdictions for those classes determined to be equal through systematic classification of positions based on objective criteria and adequate job evaluation, unless it has been agreed in accordance with HRS §89 to conduct negotiations as necessary.

Each jurisdiction, as defined in HRS §76-11, maintains its own classification system(s), thus DHRD reached out to the City and County of Honolulu, County of Kauai, County of Maui, and the County of Hawaii for information and classes of work from their classification systems that meet the definitions mentioned in Act 63.

DHRD would like to thank the classification and compensation professionals in the Counties of Hawaii, Kauai, Maui and the City and County of Honolulu for their collaboration and contributions to this report. Without their review and assistance, this report would not have been possible.

All jurisdictions have reviewed this report and agree with the findings.

Classification Review

The County of Hawaii utilizes the Police Radio Dispatcher and Fire Radio Dispatcher series of classes, responsible for operating a 911 automated work station to obtain vital information from a caller and dispatch and coordinate appropriate personnel for emergency response. The Police Radio Dispatchers in the Hawaii Police Department are required to dispatch and coordinate the response of police personnel relative to complaints, emergencies, and other requests for police assistance. The Fire Radio Dispatchers in the Hawaii Fire Department dispatch and coordinate the response of fire, rescue, and emergency medical personnel to emergencies. The County of Hawaii utilizes Clerk-Dispatcher classes in the Department of Water Supply to dispatch personnel for water service emergencies. However, the Clerk-Dispatcher is not comparable to the level and scope of work performed by their Fire Radio Dispatchers and Police Radio Dispatchers.

The County of Kauai is equipped with Clerk Dispatcher positions which provide dispatching services to the Department of Water, Operations Division to dispatch personnel for water service emergencies. Other Clerk Dispatcher positions are used at the Transportation Agency to dispatch buses. However, the county has indicated the work performed by these Clerk Dispatcher positions are not comparable to that of the Emergency Services Dispatcher positions.

The County of Maui also uses Clerk Dispatcher positions that align with the category 1 definition, which provide dispatching services in the Department of Water Supply, Field Operations Division. However, the type of work performed by the Clerk Dispatcher positions differ from the county's Emergency Services Dispatcher positions, in that Clerk Dispatcher positions dispatch personnel for water service emergencies.

The City and County of Honolulu utilizes Clerk Dispatcher and Water Service Clerk Dispatcher positions which provide water service complaint and radio-telephone dispatching services in the Department of Facility and Maintenance and Board of Water Supply. The work provided by the Clerk Dispatcher and Water Service Clerk positions are not comparable to their other classes, such as the Police Communications Officer.

Through shared discussion, the County of Kauai, County of Maui, and City and County of Honolulu have expressed that their classes are classified properly and assigned to the appropriate salary range. The County of Hawaii is reviewing its Fire Radio Dispatcher and Police Radio Dispatcher series.

Within the State Executive Branch, DHRD surveyed the Department of Transportation, Department of Public Safety, and the Department of Land and Natural Resources to determine whether they have classes of work and/or positions that align with one of the categories specified in Act 63. These departments were selected as they use classes of work that meet the definition of "emergency workers" as prescribed in section 707-700 (1) and (2), Hawaii Revised Statutes, such as Deputy Sheriff, Harbor Enforcement Officer, Conservation and Resources Enforcement Officer, and Airport Firefighter. The Department of Health was surveyed as the Hawaii State Hospital telephone operators were specifically identified in Act 63.

The Department of Transportation uses Airport Operations Controller and Harbor Traffic Controller positions that align with the category 1 definition in the Harbor and Airport Divisions. The duties of these Airport Operations Controller and Harbor Traffic Controller include dispatching personnel for harbor and airport operations related emergencies. The Department of Public Safety and the Department of Land and

Natural Resources use Clerk Dispatcher positions that meet the category 1 definition in the Sheriff Division and Division of Conservation and Resources Enforcement Division.

Lastly, the Department of Health is equipped with Telephone Operator positions that meet the category 1 definition in the Adult Mental Health Division. The duties of these Telephone Operator positions include providing telecommunication services to the Hawaii State Hospital.

DHRD will continue to work with the departments on the review of their positions to determine if changes to the classification is warranted.

Compensation Review

The majority of public sector employees, including emergency dispatchers, are hired from the local labor market. When an organization predominantly hires from the local workforce, a major factor besides ability to pay, that influences wages are salaries paid in the local labor market. The competitiveness of public sector wages is determined by comparing public sector wages to the local labor market in Hawaii.

In this case, there are no comparable jobs in the private sector in Hawaii that match the emergency dispatcher descriptions found in Act 63. While it is not prudent to set salaries based on wages outside of Hawaii, a salary analysis was completed with data from the "National Compensation Association of State Governments (NCASG) 2021 Salary Survey" to determine how the emergency dispatchers in Hawaii compare to similar jobs nationally. The Law Enforcement Dispatcher job in the survey was used to make this comparison. The Law Enforcement Dispatcher is the journey-worker level that dispatches law enforcement and emergency services to specific locations using maps and guides and manages the flow of incident related information to and from field units. Errors, dissemination of misinformation, or lack of response may result in loss of life. The job requires a state dispatcher certification.

The following chart lists police/fire/emergency journey-level dispatcher classes that are comparable to the description for Law Enforcement Dispatcher.

The county emergency dispatcher salary ranges are well above the national salary range average minimum (by 27% and 37%) and salary range average maximum (by 20% and 29%) rates¹. The average emergency dispatcher salary is \$56,627, which is 25% more than the NCASG national average salary of \$45,217¹ Based on this external comparison, the emergency dispatcher salaries are competitive.

Conclusion

It was found that emergency dispatcher classes in the Counties of Kauai, Maui and the City and County of Honolulu are properly classified and assigned to the appropriate salary ranges in their bargaining unit. The County of Hawaii's Classification and Compensation team, at the time the jurisdictions discussed the report requirements, was already independently reviewing its Fire Radio Dispatcher and Police Radio Dispatcher series to assure equal pay for equal work as provided in HRS §76-1. The State will continue to work with its departments to review their classes of work.

¹ The cost of living or consumer price index (CPI) is not included in the calculation because it reflects the changes in the price of goods and services in a specific geographic area and should not be used to calculate salaries paid in different labor markets. The Bureau of Labor Statistics specifically states that cost-of-living data should not be compared among different locations and does not show whether prices or living costs are higher or lower in one area relative to another area or the United States as a whole.
