  - b. Consumer Price Index for All Urban Consumers (CPI-U) - Hawaii and national projections and/or past rates
  - c. Cost of living - Hawaii and national projections and/or past rates

- d. Inflation projections and/or past rates
  - e. Recruitment trends – projected and past
  - f. Salaries of comparable positions nationwide, and the City and County of Honolulu and counties in Hawaii
  - g. Workload projections and past trends
  - h. Benefits impacted by salaries
  - i. State budget projections, including revenue projections, and actual and possible policy decisions locally and nationally
  - j. Hawaii and the national economy
  - k. Past and present trends in salaries that were recommended and determined by the State Constitution, Legislature, and commissions
  - l. Comparable private sector salary trends, projections, and/or past amounts
7. Discuss tentative salary recommendations for the governor, lieutenant governor, and cabinet members – ensure competitiveness with similar positions locally and nationally.
  8. Discuss tentative salary recommendations for judges/justices – address minimal increase issue from the last Commission.
  9. Discuss tentative salary recommendations for legislators – align their compensation with that of City and County of Honolulu’s council members.
  10. Planning of Commission’s tasks and agenda items for the next meeting.
  11. Adjournment.
